How long we will keep your personal data for	<p>We will normally keep your personal data for 7 years. In the event of an incident in which you are involved in any way, we may keep your personal data for longer.</p>
Your rights in respect of your personal data	<p>You have the right of access to your personal data and, in some cases, to require us to restrict, erase or rectify it or to object to our processing it, and the right of data portability.</p>
